### **New Business:**

**Motion** Wallet, second Dreikorn to give preliminary approval of CPV's Lot Consolidation Plan conditioned upon CPV obtaining a Highway Occupancy Permit from the Pennsylvania Department of Transportation relating to access to the Project to and from State Route 271. Vote-3 yes.

**Motion** Wallet, second Dreikorn to approve the CPV Preliminary Land Development Plan based on meeting the following conditions:

- 1. Compliance with any comments by the Cambria County Planning Commission.
- **2.** As part of the Final Land Development Plan approval for the Project, Applicant shall submit and receive approval from the Board of Supervisors of a final lighting plan satisfying the requirements of Sections 1009.D and 1010.C(b)(5) of the Zoning Ordinance.
- **3.** As part of the Final Land Development Plan approval for the Project, Applicant shall submit and receive approval from the Board of Supervisors of a signage plan satisfying the requirements of Section 1010.C(b)(5) of the Zoning Ordinance.

- **4.** As part of the Final Land Development Plan approval for the Project, Applicant shall submit and receive approval of a final stormwater management plan satisfying the requirements of Section 1010.C(b)(7) of the Zoning Ordinance. The stormwater management plan shall comply with the applicable requirements of the Jackson Township Stormwater Ordinance and the Pennsylvania Department of Environmental Protection regulations codified in 25 Pa. Code Ch. 102.
- **5.** As part of the Final Land Development Plan approval for the Project, Applicant shall submit and receive approval from the Board of Supervisors of a final Emergency Response Plan satisfying the requirements of Section 1008.E of the Zoning Ordinance relating to hazardous chemical management plan requirements.
- **6.** As part of the Final Land Development Plan approval for the Project, Applicant shall submit copies of all applicable permits issued by the Pennsylvania Department of Environmental Protection (PaDEP) for waterway obstructions, stream or wetland encroachments, a water quality management permit, NPDES permit and other permits that may be required from the PaDEP for sewage systems and / or discharges of stormwater.
- **7.** As part of the Final Land Development Plan approval for the Project, Applicant shall submit evidence of approval of an Erosion and Sedimentation Control Plan by the Cambria County Conservation District.

A vote by the Jackson Township Supervisors was then taken. Vote-3 yes.

**Motion** Dreikorn, second Wallet waiving the scale requirements set forth in the Subdivision & Land Development Ordinance (see below) for the CPV submission.

The site plan materials included in the Land Development Plan Application reflect various drawing scales instead of one inch equals 200 feet as described in Section 211 of the SALDO. Such modifications in scale are hereby approved based on the large size of the project site compared to the typical size of project sites for which land development plan approval is requested.

The motion was opened up to public comment and there were none. A vote was then taken. Vote-3 yes.

**Motion** Wallet, second Dreikorn to approve Rosebud Mining Company Road Bond for a six month period to continue using 1.32 miles of Pike Road East. Vote-3 yes.

**Motion** Dreikorn, second Wallet on approving the time sheets from December 6, 2015 through December 19, 2015, December 20, 2015 through January 2, 2016 and January 3, 2016 through January 16, 2016. Vote-3 yes.

#### **Public Comments:**

Clair Michaels said, if this power plant goes through, why don't they put a stop light during the time of construction so there is no accidents because you're going to have a lot of vehicles going on and off Rt. 271. Chairman Baker said there is a meeting coming up with PennDOT. Mike Resca of CPV said, we had meetings with PennDOT to understand what they would require during construction. Dave Minnear of L. Robert Kimball Engineers said, we met with PennDOT in Hollidaysburg and they didn't think they would require anything post construction but to discuss the actual construction period, they would like to meet to any safety issues or concerns. Resca added, safety would be our primary concern. Michaels then said, you did a pretty good job plowing snow this past storm.
