Ed Westrick said, I would personally like to thank you guys for the job that's being done on the pond down there. I think you're doing a great job and it's coming along pretty good and we also need to thank Jackson and East Taylor Fire Companies for the job they did on Sunday in putting in the cribs for the fish habitats. **Vice Chairman Wallet** said, we would like to thank you Ed for all you did down there too. **Westrick** said, it's been a long time coming. **Supervisor Dreikorn** said, you think about long it's taken and then boom. . it's happening real fast which is nice. **Wallet** said, I think the concept for the pond first started in 2013. **Westrick** said, even before that we made an agreement at the Club to participate in it. **Wallet** said, well. . we're almost there. Karl Smith took the water pH and I talked to the guy at the Fish Hatchery and he said the pH is perfect, so we ordered two sets of starter fish for the initial stocking of bait fish and everything else. **Chairman Baker** said, our initial plan was to take the cribs and drag them out onto the ice and when the ice melted, they would sink to the bottom where we wanted them, but the pond never froze over this winter. In a normal year that would have worked fine but then the Fire Company had the idea of floating them out and then sinking them. That's what we did on Sunday. They attached a crib to a barrel and then floated them into position, cut the rope and the crib sunk. The JET (Jackson - East Taylor) Diving Team helped to do this along with members of both Jackson and East Taylor Fire Companies. As a thank you, we got them some pizza and wings and they enjoyed the day as much as we appreciated their help. Chief Barry Emerson said this was good experience for the young firemen.
