John and I were down there the other morning going over that. **Michaels** said, and you swept the road which is good. **Baker** added, they'll be down mowing at the beginning of the week. **Michaels** said, you did a good job plowing the roads this winter. **Supervisor Dreikorn** said, as a new Supervisor, I come out in the mornings and see how Bruce and John are planning with Dan, Road Foreman, how they're going to go through and plow the roads and where they need extra attention or have snow pushed back and this is on a daily basis as they go through the winter and it's very interesting. They know where the problem areas are and the guys are very good about coming out early when they got a storm and working through it until they get everything done. It's nice to see that.
