Public Comments:

Eugene Kist asked, How many Officers do we have in the Township? **Vice-Chairman Wallet** responded, about seven. **Kist** said, we have seven Officers here and we have no money and we're payin them. Can't we consolidate with some of these other Townships to cut costs. . we can't keep operating this way. Years ago you had 10 to 12 thousand cars coming through this Township and you had 2 part time Officers. You can eliminate a lot of the cost. . you have a School Zone and an Officer settin out here all the time. . . just put a bigger sign out there. . .a flashing sign like everybody else. . put a camera on it. You don't need an Officer there. That camera don't cost that much. and you can make citations that way.

Ed Westrick said, I'd like to comment about that Police Officer at the School Zone. I think it's doing a lot of good for the Township. Since they started doing that, you can see a lot of people going a lot slower. I think it's doing a wonderful job.

Clair Michaels said, I see you're doing something right because the Capital Reserve is increasing instead of decreasing. I'm glad to see that. Another thing. . I want to thank you and the guys who mowed the grass down past my place and the good job they did cutting the bank and everything down. I'm glad to see they do that all the time, especially when I ask them to. **Vice-Chairman Wallet** said, I'll pass that on because they like that. . they get enough of heat. **Michaels** said, the only heat they get from me is when I ask them to cut more but they did a great job.

Cameron Hoffman said, the idea of a skate park would work better moved to the vacant land along Leidy Lane further away from the ballfield, playground and pavilion at Leidy Park and homes. **John Hoffman** asked, how much land in that area is owned by the Township. **Vice-Chairman Wallet** said, I believe it goes down to the flat part at the bottom. **John Hoffman** said, from time to time the volleyball courts are used. **Wallet** said, that's good you guys considered that and that may be a good use for that property.

Eugene Kist said, Mr. Wallet. . is there any way of requesting a copy of the meeting being recorded? **Manger Hirko** replied, they're not kept after the meeting. **Solicitor Barbin** said, the recordings are for his use only to record the Minutes. **Kist** asked, do I have to bring my own recorder? **Barbin** said, yes and you're welcome to. **Kist** asked, if I bring my recorder, is there any way of certifying and documenting what is true on that recording? **Barbin** replied, no. **Kist** said, this is a public meeting and we're in the United States of America and we should have the right to request a recording of any meeting anywhere in the United States. **Vice-Chairman Wallet** said, our Minutes are public documents that anyone can read or share. **Kist** said, you're making a public document here and I should have the right to request it. **Wallet** said, that recorder is an aid for him to make sure he captures all the things that happened at the meeting. **Barbin** said, Dave's absolutely right. . he's not entitled that to legally. **Kist** said, I want that in writing and want it documented. **Ed Westrick** said, all you have to do is go on the website and the Minutes are on there every month.


Announcements:
