Motion Dreikorn, second Baker to approve the Subdivision of land on Swan Drive from Karen Stevens to CPV Fairview LLC. Vote-2 yes with Wallet abstaining.

Motion Wallet, second Dreikorn to approve Rosebud Mining Company Road Bond for a six month period to continue using 1.32 miles of Pike Road East. Vote-3 yes.

Motion Dreikorn, second Wallet on approving the time sheets from June 19, 2016 through July 2, 2016 and July 3, 2016 through July 16, 2016. Vote-3 yes.

Other New Business:

Motion Wallet, second Dreikorn to enter into an Easement with Sharon Wiktor on Adams Avenue to install approximately 28 feet of guardrail on her property. The Motion was opened up to public comment and there was none. **Dreikorn** said, what she's looking at is the sharp turn by Grata's. She's got a problem with vehicles coming around the turn in the wintertime and coming through her yard and ending up in her front porch. **Baker** said, about a year ago, one took her garage out. A vote was then taken. Vote-3 yes.

As you know I sent an email about speeding on Pike Road and when I came home today there were cops doing speed control and it's very much needed. **Supervisor Wallet** said, our residents are our eyes and ears out there. **Keilman** said, I'm sure you always here the complaints and I just want to come down and say thanks. **Chairman Baker** said, speeding is a problem on every road. When we're there, they slow down but as soon as we go. **Keilman** said, my wife and I are concerned because there's quite a bit of foot traffic down the road from The Village home as well as ATV's crossing combined with vehicles going higher rates of speed on Pike Road. My wife and I really appreciate you're being out there enforcing the speed limit. **Baker** added, we're out there doing school time too. There were 10 people pulled over today while they were out there.

Clair Michaels said, they mowed down along the road and done a good job. **Supervisor Wallet** said, we like to hear that. **Michaels** said, he did a real good job. He reaches as high as he can go.
