

**SUPERVISOR'S MEETING
September 12, 2013**

The Jackson Township Supervisors held their regular meeting at 8:00 a.m. at the Jackson Township Municipal Building. Members present were Supervisors Bruce Baker, John Wallet, Secretary-Treasurer / Manager Dave Hirko and Solicitor Bill Barbin. The meeting was called to order by Chairman Bruce Baker with the Pledge of Allegiance to the flag.

Board Roll Call was taken with Supervisors Baker and Wallet present. Supervisor Mark Westrick was unable to attend.

New Business:

Larry Custer, Executive Director of the **Cambria County Redevelopment Authority** said, this first Resolution is a revision to the 2011 CDBG Program. As you know, we recently completed the construction of the Pressure Reducing Valve Station on Chickaree Hill Road and as a result of that Project, there is still an amount of about \$25,000 that is unexpended. We talked about this and what we would like to do is use that money at the Senior Center. It needs re-pointed, repaired and there is other work that needs done at the Center. This Resolution transfers that \$25,000 of unexpended money towards the Senior Center. We already had some money put away for the Senior Center in the 2011 Program of about \$30,000. An Architect has been there and will be submitting a proposal for the architectural services that need to be done. The Architect is Kasun from Hollidaysburg who is associated with Keller Engineers, the Township Engineer. **Supervisor Wallet** said, they'll develop plans for repairs and then you'll put them out for bid. . correct? **Custer** added, and prepare the drawings and specifications.

Motion Wallet, second Baker to approve revision to the 2011 CDBG (Community Development Block Grant) Program. Vote-2 yes.

Larry Custer said, the next Resolution concerns the 2013 CDBG Program. For the first time in many years, the Township actually received a little bit of an increase . .about \$700 more than what we had last year. This years allocation is \$83,548. We held two Public Hearings and there were comments and it was felt that the most appropriate use of these funds was to continue on the Sanitary Sewer Project on Chickaree Hill Road. This allocation which would be the third allocation towards that project should extend a public sewer line all the way up to Wagner Road. In this Resolution also have a little allocation in there for the Senior Center just to cover us in the event we don't have enough money from the 2011 Funds.

Motion Wallet, second Baker to approve the 2013 CDBG (Community Development Block Grant) Program. Vote-2 yes.

Other New Business:

Supervisor Wallet said, at the last meeting we talked about the Fishing Pond Project. Since then, we received the permit applications for DEP, Army Corp. and the Cambria County Conservation District. They've been executed and sent back to the Engineer so hopefully we'll get the whole submittal package off to them in a week or two. It's another step in progress.

Public Comments:

Herb Wilson said, We're here on behalf of Mallory Lane and we're looking to possibly turn it over to the Township. Here's a survey of it. Mallory Lane is about 1,000 feet long. The property owners on the East side of Mallory Lane decided to get together and dedicate the 3 foot additional needed to the 30 foot existing road to make the required 33 feet to qualify as a Township street. We brought a survey to show you where the right-of-way is. Besides myself, Gabodas and Hegedus's have donated the extra 3 feet needed. **Solicitor Barbin** asked, and the 30 feet on the other side is an existing easement? **Wilson** replied, yes. **Chairman Baker** asked, the cul-de-sac isn't there yet, is it? **Wilson** answered, no but it's laid out with surveyor sticks. **Supervisor Wallet** asked, you understand Herb that it would have to be developed before we could take it over? It would have to be improved . .we can't improve it. **Barbin** said, it would have to meet minimum

PennDOT standards for us to take it over. **Barbin** said, it would need six inches of approved stone. PennDOT would have to approve and say before we take it over, it meets the standards required for us to receive Liquid Fuels. That's basically a six inch stone base, 18 foot cartway and no apparent drainage problems. That's what they look for and if all of their requirements are met, they'll give us permission to take it over. **Baker** said, we'll start the process here for you. We'll get with PennDOT and take a look at it and get their comments. I'll keep you apprised to where it's at.
