George Burkey said, we are down to about 100 people or households who haven't yet pressure tested their system. We're getting a couple more every day. **Solicitor Bill Barbin** said, and now your pumps work and you don't have any problems with pump stations anymore. **Burkey** said, we still have some pump problems and the grinder pumps are getting old so some of them need replaced. When we approve sewage for new subdivisions,

we're getting to a problem where they can have sewage but a lot of times, they're going to have to buy grinder pumps because gravity flow is not possible in some areas. We don't supply them anymore except the ones on the initial project. **Supervisor Dreikorn** asked, are the ones under that initial project still covered by JETSA? **Burkey** replied, yes and the only time we even charged anybody is if they put something down their system that ruined the pump.
