Public Hearing on Proposed Ordinance # 176

Attorney Myron Markovich opened the Public Hearing and said, the notice of this hearing was published in the Mainline Newspaper. In addition the Ordinance, Amendment and Zoning Map was presented to the Cambria County Planning Commission and after discussion, they recommended approval with a vote of 7 to 0 for the Amendment in it's entirety. In addition the notice of this hearing was posted outside of this building. **Attorney Markovich** asked if there were any public comments and there were none. If the Board has had ample opportunity to review the Amendment to the Zoning Map and changes to the Zoning Ordinance, they could approve the passage of this Ordinance with a motion.

Motion Wallet, second Dreikorn to approve Ordinance No. 176 amending Zoning Ordinance No. 168 in regards to permitting power generation facilities in certain areas of the Township as a conditional use and to modify the Township Zoning Map to expand the Light Industrial District and modify other related provisions.
