MULTI-MUNICIPAL COMPREHENSIVE PLAN ADOPTION

WHEREAS the firm of Richard C. Sutter and Associates, Inc., at the direction of the Township of Jackson, Cambria County, has prepared, working in conjunction with the Central Cambria Coalition Multi-Municipal Comprehensive Plan Steering Committee, a Multi-Municipal Comprehensive Plan for the Townships of Jackson and Cambria, and Borough of Ebensburg, dated 2008, in accordance with the Pennsylvania Municipalities Planning Code, Act 247, as reenacted and amended; and

WHEREAS a completed copy of the Multi-Municipal Comprehensive Plan was provided to the Cambria County Planning Commission, contiguous municipalities, and the local School District for review and comment, and

WHEREAS the Central Cambria Coalition Multi-Municipal Comprehensive Plan Steering Committee has recommended the adoption of the Comprehensive Plan by the Jackson Township Board of Supervisors, and

WHEREAS the Township of Jackson in conjunction with the Central Cambria Coalition Multi-Municipal Comprehensive Plan Steering Committee, Cambria County has conducted a duly advertised Public Hearing on Wednesday, October 29, 2008 as required by the Pennsylvania Municipalities Planning Code, Act 247, as reenacted and amended, and has considered all comments and recommendations submitted at said Public Hearing.

NOW, THEREFORE, BE IT RESOLVED that the Township of Jackson, does hereby adopt the Multi-Municipal Comprehensive Plan for the Central Cambria Coalition Comprehensive Plan Steering Committee, including all the maps, charts, textural material, and other materials contained therein intended to form the whole of the Plan.

BE IT FURTHER RESOLVED, that the Board of Supervisors of the Township of Jackson encourages all public officials, appointed officials, the business community, civic associations, and the general public to take into consideration the recommendations and proposals contained within the Multi-Municipal Comprehensive Plan when dealing in matters concerning the future physical, social and economic development of Jackson Township and its fellow Central Cambria Coalition members

Dear Dave:

Find enclosed a copy of the Adoption Resolution for consideration by the Jackson Township Board of Supervisors at their upcoming November 13 meeting. On Wednesday, October 29, 2008, each of the three (3) municipalities who are a part of the Multi-Municipal Comprehensive Plan (Jackson Township, Cambria Township, and Ebensburg Borough) held their Public Hearing as required by the Pennsylvania Municipalities Planning Code, (MPC), Act 247, as reenacted and amended. Previously, the Planning Commissions of the three (3) municipalities held their required Public Meeting on September 24, 2008. Each of the three (3) municipalities can now adopt the Multi-Municipal Comprehensive Plan by Resolution.

As part of the contract between the three (3) municipalities and DCED, we are required to send a copy of the Multi-Municipal Comprehensive Plan to DCED after adoption, as well as the Adoption Resolutions from the three (3) municipalities. In order for the three (3) municipalities to start implementing the recommendations of the Plan, DCED needs to see those Resolutions so that the LUPTAP Grant can be approved and work can begin upon Phase II, Implementation Initiatives and Ordinances.


Kindly have the enclosed Adoption Resolution passed by the Township Board of Supervisors at your November 13 Supervisor's meeting to adopt the Multi-Municipal Comprehensive Plan. Forward a signed copy to us so we can continue moving ahead with the Planning Program
