Approval of February 19, 2008 Minutes: Tim Davis made a motion to approve the  
February minutes as read; Al George seconded the motion; minutes approved.

1. New Board Member to the Recreation Commission: The supervisors appointed  
Dennis Grove to the board. A welcome was extended to Dennis.
2. Mitchell Park Update:
  - a. Contracts will be sent out by Dave Hirko to Beauty Lawn for weed and  
feed application and Ehrlich for crawling insect control
3. Leidy Lane Park Update: none
4. Veteran's Park Update:
  - a. Water Authority planning to supply water to various areas.
  - b. Preliminary approval for grant
  - c. Banner Program for Veteran's Park under consideration
5. Events and Activities Update:
  - a. Easter Egg Hunt – success; Dave Hirko made the recommendation to hold  
the event from 12-1 next year
  - b. Summer Concert Series: Advertising will begin in May; Rec members  
suggested that advertising begin immediately. Eric will check with Dave  
Hirko as to when advertising can begin
  - c. Fishing Derby: planning in progress; stocking will be held May 5.
  - d. Atlantic City Bus Trip: there are currently 2 buses planned
  - e. Heritage Festival: This year will feature a Petting Zoo (Living Treasures),  
a Car Cruise Friday evening and tractor show by Highlander Tractors.  
Currently investigating space for the tractor show. There will be a Heritage  
Festival meeting April 28; all recreation board members are welcome to  
attend.

6. Other Items Concerning Recreation:
  - a. Porta Johns – will be placed at fields; however, they will be requested earlier next for the Easter Egg hunt
  - b. Updates to Parks division among board members:

  - c. Trick or Treat: JTFD will sponsor Trick or Treat and provide monitoring and protection throughout the township.
  - d. Absent vs. Excused members: Discussion related to the motion made at the February meeting related to absent vs excused members.
