Monthly Meeting  
March 26, 2013

**CALL TO ORDER**

WALTER DITCHCREEK, CHAIRMAN, OPENED THE MEETING WITH A PRAYER AND THE PLEDGE OF ALLEGIANCE. Others board members in attendance were John Wallet, Secretary; Ray Dodson, Treasurer; and Robb Piper, Vice-Chairman and Don Hrapchak, Assistant Sec./Tres. Others present were Pat Mulchay & Kyle Fritz, EADS Group Engineers; Karl Smith, Foreman; Jim Deter, CPA and Debra Buksa, Office Manager. Jim Lauffer from the Nanty Glo Journal and Mark and Andrea Sossong, Swigle Mountain Residents also attended.

**PUBLIC COMMENTS:**

Mr. Sossong complained that he had no water pressure on the second floor of his home. If anyone used water on the first floor there was no water for the second floor. He had borrowed a gauge from Karl and it was reading 20-35 PSI. He would like to know if there was anything that the Authority could do for him. Karl said that he would check for a leak between his home and the meter, but is certain that it is not leaking; if it were leaking it would show on his bill. Pat explained that based on Mr. Sossong location, level with the tank, that 30-35 PSI is the best he will get; DEP requires 20-25 PSI. His only other options would be to install a pneumatic tank. John suggested that to L/B Water, they could help. At this time, Mrs. Sossong voiced that she feels that the Authority should help with this problem. They were forced to take the water and can not actually use it. Pat reiterated that JTWA meets DEP's standards.
