A recap of the workshop between JTWA and ETWA was given. Karl, Pat and Mark Muir tried to talk to Kim Lauffler regarding a right-of-way with no luck. Frank Svencer agreed to a right-of-way for \$500.00. The original interconnect design called for two meters, to drop the costs for both authorities the design will be changed to one meter that can be turned around depending which authority would be pulling water. The estimated cost is now approximately \$28,000. The cost of the permit from DEP will be split between the authorities. Pat had talked to CJ and he is going to start preparing the agreement between ETWA and JTWA.
