**CALL TO ORDER**

WALTER DITCHCREEK, CHAIRMAN, OPENED THE MEETING WITH A PRAYER AND THE PLEDGE OF ALLEGIANCE. Others board members in attendance were John Wallet, Secretary; Raymond Dodson, Treasurer; and Robb Piper, Vice-Chairman. Don Hrapchak, Asst. Treasurer / Secretary was absent. Others in attendance were Pat Mulchay, EADS Group; Jim Deter, CPA; Karl Smith, Foreman, Fred Meier and Debra Buksa, Secretary. Covering for the *Nanty Glo Journal* was Allison Graver. Other in attendance were Joe & John Hancharick, Donna Hibbard and Clare Silk.

Solicitor, CJ Webb announced that an executive session was held prior to the monthly meeting concerning possible litigation with no formal actions taking place.

**PUBLIC COMMENTS:**

Joe & John Hancharick, Donna Hibbard and Clare Silk, homeowners, presented their concerns with the low water pressure in their homes. Karl explained that he had checked the pressure and the level is within DEP standards. He explained further that the residents have volume with limited pressure due to the elevation and internal pumping is also restricting water. The residents insisted that the Authority had installed pumps for other residents along this area. Ms Silk feels if the Authority gives one a pump all should receive one. (*Please see note following engineer's report*) After several minutes of debate, the Board decided that our engineer will accompany Karl and Fred before the next meeting to assess the situation. The findings will be brought before the Board at the next monthly meeting.
